| Why? | <p>Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.</p> |
| What? | <p>The types of personal information we collect and share depend on the product or service you have with us. This information can include but is not limited to:</p> <ul style="list-style-type: none"> • Social Security Number and Investment Experience • Assets and Income • Account Balances and Transaction History <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p> |
| How? | <p>All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons mABC Investment Advisors chooses to share; and whether you can limit this sharing.</p> |

| How does mABC protect my personal information? | <i>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</i> |
| How does mABC collect my personal information? | <p><i>We collect your personal information, for example, when you:</i></p> <ul style="list-style-type: none"> <i>• open an account or perform transactions</i> <i>• make a wire transfer or tell us where to send money</i> <i>• tell us about your investment or retirement portfolio</i> <p><i>We also collect personal information from others in the normal conduct of our business</i></p> |
| Why can't I limit sharing? | <p><i>Federal law gives you the right to limit only:</i></p> <ul style="list-style-type: none"> <i>• sharing information about your creditworthiness for affiliates' everyday business purposes</i> <i>• affiliates from using your information to market to you</i> <i>• sharing for non-affiliates to market to you</i> <p><i>State laws and individual companies may give you additional rights to limit sharing.</i></p> |

| Others | <i>mABC does not have any affiliate companies, defined as companies related by common ownership or control. "Others" include non affiliated companies such as your account custodian (e.g. Fidelity, Scottrade or 401k provider) and service providers (Morningstar, Constant Contact),</i> |
